- Additional fees where goods or facilities are not ready or available at the time the supplier has advised and therefore an additional inspection visit is required

SGS fees will be calculated on the basis of the invoice value submitted by the exporter or importer.

These fees will be due regardless of whether, after the assessment of the goods, the exporter or importer is unable to provide the information or documents necessary for the final issuance of the CoC, or for any reason does not proceed with the shipment of the goods.
